Looking at the top half of the table, the common denominator is universal scarcity in the current global market. That situation is unlikely to change in the short to medium term.

It will be interesting to look at Q1 2022 results when they are released next month. The last quarter has seen supply challenges relating to large format cigars such as Double Corona. Both the Partagas Lusitania and the Hoyo de Monterrey Double Corona are highly sought after and almost impossible to find.

There may indeed be some significant Bond Roberts 25 movement afoot.

Market Report – What is rare?


What is rare?

We have been saying it for a while: "Bond Roberts auctions aged, rare and vintage cigars". But like most people who enjoy handmade cigars, sometimes we struggle with definitions: what is aged? 2 years, 5 years? What is vintage is even more complicated, but asking and answering "what is rare?" takes things to a whole new level.

In November of 2021 the Bond Roberts team determined that in the handmade Cuban cigar market, all Cohiba, even recent production of regular lines, were rare. This decision was made on the basis that inventory in more and more shops in more and more countries around the world had sold out.

The result of our re-classification was that sales of Cohiba on Bond Roberts increased from c30 auctions per month accounting for 12% of all auctions to >70 auctions per month (approaching 20% of all of our auctions).

Graph 1: Cohiba auctions on Bond Roberts, May 2020 – March 2022



That decision released 99 recent production boxes of Cohiba Cigars for auction on Bond Roberts.

Market Report – What is rare?

Since our classification change market circumstances have changed. Much as we'd love to see regular and recent production Cohiba in retail stores and therefore "not rare", our view is that it appears the opposite has happened. Cuba continues to struggle with production and demand remains sky high. As a result, rather than taking regular and recent productions off our rare list we are going to add to it as per the following table:

This list above was taken from observations made from Bond Roberts Watch lists and within the Friends of Habanos and James J Fox businesses and polling of their customers. There are three themes arising:

Prominentes

Bond Roberts believes all *Prominentes* sized cigars (49 x 194) are now rare. The implications are haunting for anyone who remembers just what it was like in the late 1990s when demand far exceeded supply resulting in whole sections of the Habanos portfolio, but particularly large cigars, being inaccessible to consumers across large parts of the world. So far, retailers across the world have been advised by their distributors that the current hiatus is temporary and they can expect the supply situation to improve in the 2nd half of 2022. Whatever happens, everyone is hoping we don't get the same 2000-2002 response as was experienced after the shortage of the 1990s.

Is this a long goodbye?

Bond Roberts has classified as rare the *Diplomaticos* No 2, the *La Gloria Cubana* Medaille d'Oro No 4, the *Sancho Panza* Belicosos and *Saint Luis Rey*'s Regios. In each case, it's the last vitola in commercial production in the marca, and in each case the decision to classify as rare is based on the scarcity of stock in the primary retail market. The inference, however concerning is still clear: what is the future for these historic brands?

Survey Bias

Bond Roberts is a joint venture between Friends of Habanos and James J Fox, with the former having a Global e-commerce orientation with a Pacific Cigar Company supply side perspective and the later having a Great Britain and Ireland orientation with a Hunters & Frankau supply side perspective. What we learned in our discussions on this subject is that what is rare for one isn't necessarily rare for the other. This highlights natural deviations in supply around the world; when inventory is scarce it isn't divided equally between all markets, it is allocated to some markets at the expense of others, with the next consignment or inventory of the next brand intended to compensate for local shortages. Or put another way, 20 master cases of a product aren't easily split between 50 markets. As a result, our list has been compiled from our own, our customers (via watchlist functionality) and our Joint Venture partners customers' subjective perspectives. Please let us know your views on the list as we intend to keep our definition of what is rare under review.
